- General Election Report November 4, 2025 (Candidates in the General Election)**- no later than 7 days before the Municipal General Election. DUE October 28, 2025, by 5:00 p.m.
- Post-General Report (Candidates in the General Election)**- no later than 30 days after the Municipal General Election. DUE December 4, 2025, by 5:00 p.m.
